FWCC is comprised of four sections: Europe and Middle East; Africa; Asia West Pacific; and Section of the Americas. Established in 1937 its purpose is to endeavour to reach and build bridges across the various theological traditions and cultural differences among Friends globally and to give opportunity to Quakers from all traditions to meet, worship and share our common heritage.

FWCC where it is felt appropriate tries to present a Quaker voice and message to the World, and to represent Friends on the global stage. This is particularly evident in our role of oversight for the two Quaker United Nations Offices in Geneva and New York, and in our developing work on both sustainability and issues of privilege and historical injustice related to colonialism. FWCC plans and holds World Plenary Meetings every 7-10 years and our next such meeting will be in South Africa in 2024.

through long-term commitment to international processes, focussing on peacebuilding and disarmament; human rights and migration; sustainable and just economic systems; and human impacts of climate change. Our staff are trusted experts and convenors, often working behind the scenes, with diplomats, UN agency staff and others. We find our "quiet diplomacy", at Quaker House, in UN corridors, and increasingly online, helps change attitudes and find innovative responses to difficult issues.

QCEA brings a vision of peace, justice and equality to Europe and its institutions. We advocate for a new approach to security, focusing on nonviolent approaches to conflict. We promote policies that recognise the intrinsic equality of all people everywhere and reduce fear of the 'other'.
